### APPLICATIONS

Ideal for cleaning stubborn or ingrained dirt from all hard surfaces. Invaluable where water is not readily available.

Particularly useful in the aviation industry and other areas where the use of hydrocarbon propellants would not be desirable. Suitable for use on business machines and office equipment, domestic appliances, worktops, walls, machinery, plant and equipment, cabinets, casings, formica, vinyl and leatherette upholstery.\*

Apply from a distance of 6" - 9" (15 - 25 cm). Leave for 10 - 20 seconds and wipe away with a clean, damp cloth.

**Do not apply directly onto keyboards or similar equipment.**

\* Always test a small, inconspicuous area for colour fastness before general use.
